

RESOLUTION 220503-12

A RESOLUTION DIVIDING LARAMIE COUNTY INTO SIX (6) ELECTION DISTRICTS AS REQUIRED BY W.S. 22-7-101

WHEREAS the Board of County Commissioners of Laramie County, Wyoming is required by W.S. 22-7-101, upon the advice or recommendation of the County Clerk, no later than the first regular meeting in May in every general election year shall divide Laramie County into no more than thirty (30) election districts; and

WHEREAS the Sixty-Sixth Session of the Wyoming State Legislature has recreated W.S. 28-2-116 through 28-2-119 modifying State Legislative Districts; and

WHEREAS notice of the proposed changes detailed in this resolution and its referenced boundary descriptions were provided to the chairperson of each political party in Laramie County and notice describing the proposed changes was duly published according to law;

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of Laramie County, State of Wyoming, that: Laramie County be and is divided into six (6) election districts, the boundary descriptions of which are fully incorporated herein and are on file and available for public inspection on the website and in the offices of the Laramie County Clerk.

District #1

All areas annexed to the City of Cheyenne within an area described as follows:

Commencing at a point beginning at the intersection of the centerline of Dell Range Blvd and the centerline of Converse Ave; **THENCE** Southerly along the centerline of Converse Ave to the intersection of the centerlines of E Lincolnway and Converse Ave; **THENCE** Westerly along the centerline of E Lincolnway to the intersection of the centerlines of Logan Ave and E Lincolnway; **THENCE** Southeasterly along the centerline of Logan Ave to the intersection of the centerline of Nationway; **THENCE** Southeasterly along the centerline of Nationway to the intersection of the E Sect line of Sect 32, T14N, R66W; **THENCE** Southerly along the E Sect line of Sect 32, T14N, R66W to the SE Sect corner of Sect 32, T14N, R66W; **THENCE** Westerly to the East boundary of Original City; **THENCE** Southeasterly along the East boundary of Original City to the SE corner of Original City; **THENCE** Southwesterly along the S boundary of Original City to the intersection of the centerline of Morrie Ave; **THENCE** Southeasterly along Morrie Ave to the intersection of the centerline of E Fox Farm Rd; **THENCE** Westerly on E Fox Farm Rd to the intersection of the centerline of S Greeley Hwy; **THENCE** Southerly along the centerline of S Greeley Hwy to the intersection of the S Sect line of Sect 33, T13N, R66W; **THENCE** Westerly along the S Sect line for the next seven (7) Sects to the SW corner of Sect 32, T13N, R67W; **THENCE** Northerly along the W Sect line for the next nine and a half (9½) Sects to the intersection of the centerline of Polo Ranch Rd; **THENCE** Southeasterly along the centerline of Polo Ranch Rd to the intersection of Round Top Rd; **THENCE** Northerly along the centerline of Round Top Rd to the NW corner of Sect 15, T14N, R67W also known as the NW corner of FE Warren AFB; **THENCE** Around the N and E Boundaries of FE Warren AFB to the intersection of the centerline of Central Ave; **THENCE** Southeasterly along the centerline of Central Ave to the intersection of the centerline of Yellowstone Rd; **THENCE** Northerly along the centerline of Yellowstone Rd to the intersection of the centerline of Dell Range Blvd; **THENCE** Easterly along the centerline of Dell Range Blvd to the intersection of the centerline of Dry Creek; **THENCE** Easterly along the centerline of Dry Creek to the intersection of the centerline of Dell Range Blvd; **THENCE** Easterly along the centerline of Dell Range Blvd to the point of beginning.

District #2

All areas annexed to the City of Cheyenne within an area described as follows:

Commencing at a point beginning at the intersection of the centerline of Dell Range Blvd and the centerline of Converse Ave; **THENCE** Easterly along the centerline of Dell Range Blvd to the intersection of the centerline of Cleveland Ave; **THENCE** Southerly along the centerline of Cleveland Ave to the intersection of the centerline of Rio Verde St; **THENCE** Easterly along the centerline of Rio Verde St to the intersection of the centerline of Pierce Ave (at this point Rio Verde St changes to Green River St); **THENCE** Easterly along the centerline of Green River St to the intersection of the centerline of Van Buren Ave; **THENCE** Southerly along the centerline of Van Buren Ave to the intersection of the centerline of Eastview St; **THENCE** Easterly along the centerline of Eastview St to the intersection of the centerline of Hayes Ave; **THENCE** Northerly along the centerline of Hayes Ave to the intersection of the centerline Greenmeadow Dr; **THENCE** Westerly along the centerline of Greenmeadow Dr to the intersection of the E boundary line of Valley Vista Subdivision; **THENCE** Northerly along the E and N boundary of Valley Vista Subdivision to the intersection of the centerline of Dell Range Blvd; **THENCE** Easterly along the centerline of Dell Range Blvd to the intersection of the centerline of US Hwy 30; **THENCE** Easterly along centerline of US Hwy 30 to the SE corner of Sect 21, T14N, R65W; **THENCE** Northerly along the E Sect line for the next five (5) Sects to the NE corner of Sect 33, T15N, R65W; **THENCE** Westerly along the N Sect line for the next fourteen (14) Sects to the NW corner of Sect 32, T15N, R67W; **THENCE** Southerly along the W Sect line for the three and a half (3½) Sects to the intersection of the centerline of Polo Ranch Rd; **THENCE** Southeasterly along the centerline of Polo Ranch Rd to the intersection of Round Top Rd; **THENCE** Northerly along the centerline of Round Top Rd to the NW corner of Sect 15, T14N, R67W also known as the NW corner of FE Warren AFB; **THENCE** Around the N and E Boundaries of FE Warren AFB to the intersection of the centerline of Central Ave; **THENCE** Southeasterly along the centerline of Central Ave to the intersection of the centerline of Yellowstone Rd; **THENCE** Northerly along the centerline of Yellowstone Rd to the intersection of the centerline of Dell Range Blvd; **THENCE** Easterly along the centerline of Dell Range Blvd to the intersection of the centerline of Dry Creek; **THENCE** Easterly along the centerline of Dry Creek to the intersection of the centerline of Dell Range Blvd ; **THENCE** Easterly along the centerline of Dell Range Blvd to the point beginning.

District #3

Commencing at a point beginning at the intersection of the centerline of Dell Range Blvd and the centerline of Converse Ave; **THENCE** Southerly along the centerline of Converse Ave to the intersection of the centerlines of E Lincolnway and Converse Ave; **THENCE** Southerly along the centerline of Converse Ave to the intersection of the centerlines of E Lincolnway and Converse Ave; **THENCE** Westerly along the centerline of E Lincolnway to the intersection of the centerlines of Logan Ave and E Lincolnway; **THENCE** Southeasterly along the centerline of Logan Ave to the intersection of the centerline of Nationway; **THENCE** Southeasterly along the centerline of Nationway to the intersection of the E Sect line of Sect 32, T14N, R66W; **THENCE** Southerly along the E Sect line of Sect 32, T14N, R66W to the SE Sect corner of Sect 32, T14N, R66W; **THENCE** Westerly to the E boundary of Original City of Cheyenne; **THENCE** Southeasterly along the E boundary of Original City of Cheyenne to the SE corner of Original City; **THENCE** Southwesterly along the S boundary of Original City to the intersection of the centerline of Morrie Ave; **THENCE** Southeasterly along Morrie Ave to the intersection of the centerline of E Fox Farm Rd; **THENCE** Westerly on E Fox Farm Rd to the intersection of the centerline of S Greeley Hwy; **THENCE** Southerly along the centerline of S Greeley Hwy to the intersection of the S Sect line of Sect 33, T13N, R66W; **THENCE** Easterly along Sect line for the next seven (7) Sects to the SE corner of Sect 33, T13N, R65W; **THENCE** Northerly along the E Sect line for the next eight (8) Sects to the intersection of the centerline of US Hwy 30; **THENCE** Westerly along centerline of US Hwy 30 to the intersection of the centerline of Dell Range Blvd; **THENCE** Westerly along the centerline of Dell Range Blvd to the intersection of the E boundary line of Valley Vista Subdivision; **THENCE** Southerly along the E and N boundary of Valley Vista Subdivision to the intersection of the centerline of Greenmeadow Dr; **THENCE** Westerly along the centerline of Greenmeadow Dr to the intersection of the centerline of Hayes Ave; **THENCE** Southerly along the centerline of Hayes Ave to the intersection of the centerline of Eastview St; **THENCE** Westerly along the centerline of Eastview St to the intersection of the centerline of Van Buren Ave; **THENCE** Northerly along the centerline of Van Buren Ave to the intersection of the centerline of Green River St; **THENCE** westerly along the centerline of Green River St to the intersection of the centerline of Pierce Ave (at this point Green River St changes to Rio Verde St); **THENCE** continuing Westerly along the centerline of Rio Verde St to the intersection of the centerline of Cleveland Ave; **THENCE** Northerly along the centerline of Cleveland Ave to the intersection of the centerline of Dell Range Blvd; **THENCE** Westerly along the centerline of Dell Range Blvd to the point of beginning.

District #4

All areas not annexed to the City of Cheyenne, Laramie County, WY, unless otherwise specified, within an area described as follows:

Beginning at the SE corner of Sect 13 T12N, R65W of the 6th PM, Laramie County, WY, **THENCE** Westerly along the S Boundary line of Laramie County to the W boundary line of Laramie County, **THENCE** Northerly along said W boundary line to the N boundary line of Laramie County, **THENCE** E along the said N boundary to the NE corner of Sect 4, T19N, R65 W of the 6th PM, **THENCE** South along the Laramie County boundary to the SE corner of Sect 33, T19N, R65W of the 6th PM, **THENCE** East along the Laramie County boundary to the NE corner of Sect 1, T18N, R65W of the 6th PM, **THENCE** South along the E boundary line of Townships 18, 17, 16, 15, 14, 13, and 12N, R65W of the 6th PM, to the SE corner of Sect 13, T12N, R65W of the 6th PM located on the South boundary line of Laramie County, which is the point of beginning.

The above described area also known as Laramie County School District #1.

District #5

All areas of Laramie County, WY within an area described as follows:

All areas located East of a line beginning at the NE corner of Sect 1, T18N, R65W of the 6th PM, **THENCE** South along the East boundary line of Townships 18, 17, 16, 15, 14, 13, and 12N, R65W of the 6th PM, to the SE corner of Sect 13, T12N, R65W of the 6th PM located on the South boundary line of Laramie County.

The above described area also known as Laramie County School District #2.

District #6

All areas not annexed to the City of Cheyenne, Laramie County, WY within an area described as follows:

Those unincorporated areas known as “county pockets” located between Interstate 80 to the South, Interstate 25 to the West, Whitney Rd to the East and the City of Cheyenne boundary to the North.
